## Common Florida Mandatory Course Package Questions:

**QUESTION:** What happens once I complete this course?

**ANSWER:** Once you complete this course, you will send a copy of your certificate of completion with your application to the Florida Board of Clinical Lab Personnel (BCLP). If you already have a FL Lab license #, we report it to CE Broker.

**QUESTION:** Can I use this course if I'm Upgrading an EXISTING license to Supervisor?

**ANSWER: YES.** You can complete this course OR the Individual course title 1 Hr. HIV/AIDS Update, course code: **FM-1HIV019**.

**QUESTION:** Is this the correct course if this is my FIRST Florida renewal of an existing license?

**ANSWER: NO.** If this is your FIRST Florida renewal, order the Florida First Renewal Package, course code: **FF019**.

**QUESTION:** Is this the correct course if I am renewing an existing Florida Lab license?

**ANSWER: NO.** If you already have a FL Lab license, order the Florida Mandatory Course Package, course code: **FM019**.

**QUESTION:** Do I have to take Florida Mandatory courses EACH license cycle to renew my existing Florida Lab License?

**ANSWER: YES.** Starting with your first FULL renewal cycle, you will be required to take all 3 Florida Mandatory courses EACH license cycle in order to renew your Florida Lab License. Mandatory courses are part of the required 24 CE hours.
